



## STUDENT FINANCE 2024-2025

Each year, the **Government of Catalonia** publishes a decree establishing the fees for the provision of academic services at public universities with regard to homologated qualifications. Consequently, **these fees** apply to homologated and, thus, subsidised courses.

Fees for non-EU residents for bachelor and master degrees are 50% higher than the standard price per credit for EU residents.

UPC offers the option of payment in two instalments:

- For semestral enrolment, 60% of the enrolment fees are paid when you enrol and the remaining 40% are paid in mid-December (enrolment in the first semester) or early April (enrolment in the second semester).
- For annual enrolment, 40% of the enrolment fees are paid when you enrol, 30% in mid-December and 30% on 1 March.

## BACHELOR'S DEGREES

Enrolment fees for bachelor's degrees for EU residents are approximately €1,107 per academic year. Bachelor's degrees have a duration of 4 academic years (with the exception of Architecture Studies, which takes 5 years).

As for non-EU residents, enrolment fees are approximately €2,550 per academic year. Bachelor's degrees have a duration of 4 academic years (with the exception of Architecture Studies, which is 5 years).

## MASTER'S DEGREES

Master's degrees can have a duration either of 1 year (60 ECTS credits), 1.5 (90 ECTS credits) or 2 years (120 ECTS credits).

**Qualifying master's degree (residents, EU):** 60 credits: 1,500€; 90 credits: 2,200€; 120 credits: 2,800€.

**Not Qualifying master's degree (residents, EU):** 60 credits: 2,100€; 90 credits: 3,000€; 120 credits: 3,900€.

**Qualifying master's degree (non-residents, non-EU):** 60 credits: 6,600€; 90 credits: 9,800€; 120 credits: 13,000€.

**Not Qualifying master's degree (non-residents, non-EU):** 60 credits: 6,600€; 90 credits: 9,800€; 120 credits: 13,000€.

In the specific case of Erasmus Mundus joint masters, fees are set by the consortium of universities responsible for organising each programme.

Successful candidates must pay a fee of €300 to confirm admission and reserve their place in the course. This amount will be deducted from the enrolment fee when you officially enrol.

Please note that there is a surcharge on the fees for repeated enrolment after unsuccessful completion of the course.

## DOCTORATE PROGRAMMES

Doctorate programmes do not have tuition fees, only tutorship and administrative fees, which are approximately €600 per academic year. In the specific case of Erasmus Mundus joint doctorates, fees are set by the consortium of universities responsible for organising each programme.

PhD students could apply to different grants and research internships, funded either by UPC or by external institutions.

## INTERNSHIPS AND VISA EXTENSION AFTER STUDIES

UPC international students can apply to on-campus or external paid internships whilst studying, up to 20 hours per week.

Since 2018, there is a permit extension for students looking for a job. This allows students who have studied in Spain for at least one year, to stay for up to another additional 12 months in order to look for a job or to start their own
